Greetings to you from the Friends Committee of Selsey Medical Centre (FSMC) and especially from me as your Membership Secretary. Even though we still face the very real challenges of Covid-19, we look with hope towards a better year ahead. Have you had your jabs yet? If not, please do get them done now. It really is the best way to get this Virus under control. Our Chairman, David Webber, and all the members of the FSMC wish you well as we all strive to remain disease free.

Our membership year runs from April 1 to March 31 of the following year, so your subscription for this year is not due until April 1, 2022, and will be valid until March 31, 2023. This is confirmed on the membership renewal form enclosed with this letter. Also on the form is the opportunity to state whether you would like a receipt for your payment. If there is no response to that question, and to reduce costs, no receipt will be provided. Alternatively, if you can provide an email address, I will happily send you confirmation of your payment electronically, if requested. Please also note the paragraph concerning our compliance with the Data Protection Act.

There is also a section at the end of the form for those of our Friends who are taxpayers and who would like to register their donation under the Gift Aid scheme.

Over the past year, and despite the constraints caused by Covid-19 lockdowns, the committee has continued to respond to Practice requests designed to improve patients' experiences in the Medical Centre. Since March of 2021 we have purchased 5 touchless hand Sanitisers, an auto hands free infrared Thermometer, 3 years rental for the TV screens, an ECG machine with accessories and training package, a Dermascope with Smartphone Adaptor, a PDI Combi Doppler – for diabetic reviews, and a Healthcare Monitor Integrated System.

As you will appreciate, none of the many improvements the Friends endeavour to make on your behalf would be possible, were it not for the generosity of our members. Our annual membership fee this year, as agreed by members at our Annual General Meeting, has increased slightly to a minimum of just **£5 per person, per year** although, of course, we are always delighted to receive a larger amount if you feel able to do so and our particular thanks as always go to those who are able to donate more.
